- 2. All the empaneled suppliers shall have to submit the hard copy of Original Catalogs
  / Company Rate List / Price Proof without which no order shall be placed with the supplier.
- 3. Catalogue Price shall be verifiable. Tampering or misquoting of Catalogue Price in the bill shall render the supplier liable for blacklisting and other action as per rules.
- 4. All the empaneled suppliers are to submit the EMD, original copy of tender fee chalan
  / receipt and duly signed copies of uploaded ITRs of last 03 years in the office of the
  Tender Inviting Authority (Principal Govt. Degree College for Women, Baramulla).
- All duties. GST levies and other charges payable, shall be included in the Catalogue Price.
- 6. The offered discount should be firm for the bid validity period.
- 7. The Catalogue Price shall be FOR Govt. Degree College for Women, Baramulla.
- 8. Any clarification required by the tenderers with regard to any point mentioned in the e-

NIT can be obtained from the office of the Tender Inviting Authority (Principal Govt. Degree College for Women, Baramulla) before the last date of receipt of tenders.

- 9. The EMD shall stand forfeited without any further notice to the tenderer, if:
  - a. The tenderer indulges himself in any undesirable practice or malpractice.
  - b.The tenderer does not convey his written acceptance within the specifiedtime period.
  - C. The progress / completion of work is un-satisfactory.
  - d. The Tender Inviting Authority (Principal Govt. Degree College for Women, Baramulla)
     reserves the right to forfeit EMD if the tenderer submits incomplete documents in
     e-form orhard copy.
- 10. The successful tenderer shall have to ensure the supply of the Goods within one 15 days from the date of receipt of the supply order from the college failing which thefirm shall forfeit its cash security and CDR.
- 11. The conditional tenders shall not be accepted.
- 12. Mere turning out in the empaneled list does not mean that the college is bound to place supply orders with the vendor but will be the sole discretion of the college and will also depend upon the requirements and availability of funds.
- 13. The college will provide opportunity to all the empaneled vendors to supply the items, in case any firm fails to supply the items within the stipulated time, the firm shall cease the opportunity to get another supply order. The Tender Inviting Authority (Principal Govt. Degree College for Women, Baramulla) shall be free to purchase items through any one or more of the empaneled firms at the quoted / agreed / highest discount.
- 14. The College Principal's decision in all the matters of procurement shall be final and binding on all concerned.
- 15. Force majeure: Any failure of omission or commission to carry out the provisions of the contract by the supplier shall not give rise to any claim by either of the party to contract, if such failure of omission or commission arises from an act of God, which shall include all acts of natural calamities such as fire, flood, earthquake, hurricane or any pestilence or from civil strikes, compliance with any stature and /or regulation of the government, lockouts and strikes, riots, embargo or from any political or other reasons beyond the supplier's own control including war (whether declared or not)civil war or state or insurrection, provided that notice or the occurrence of any event by either party to the other shall be given within two weeks from the date of occurrence of such an event which could be attributed to Force majeure conditions.

- 16. The college reserves the right to cancel an order at any time without assigning any reasons. The suppliers shall not be entitled to claim any compensation against any such termination.
- 17. The College reserves the right to change or modify or amend or substitute any clause(s) in the "Terms and Conditions", if required, at any time.
- 18. In case of any dispute, the same shall be resolved initially by the mutual parties within a period of two months. In case of failure to resolve a dispute mutually, it will be subject to jurisdiction of Bramulla, court only.
- After opening the financial bid all the empaneled firms shall have to sign a contract / agreement with the Tender Inviting Authority (Principal Govt. Degree College for Women, Baramulla).
